Leachate Release Arbor Hills Landfill.

August 10, 2015, 11:00am

Caller: Dave Rettell, Advanced Disposal, [REDACTED]

Mr. Rettell informed me that there was a leachate release at the Arbor Hill Landfill over the weekend in Washtenaw County.

The landfill is located at Napier Road and Six Mile.

The force main for the leachate collection/treatment system failed. The leachate was discharged to a 2m gallon onsite stormwater retention pond that discharges to the Johnson Creek via a ditch.

They are still trying to determine the volume of leachate released, probably, in the neighbor hood of tens of thousands.

Potentially, the leachate may cause a BOD problem in the Creek

Eric Anderson (LRMD) plans to go out this afternoon to assess the impact to Wayne County and take some Dissolved Oxygen readings if he deems it is necessary.
